5. All accepted vendors will be notified within 48 hours.
6. Booth equipment such as tents, tables and chairs must fit within the 10' x 10' space provided. TENTS MUST BE WEIGHTED AND SECURED WITHOUT THE USE OF STAKES.
7. All vendors must state the items they will be offering to avoid duplications and provide an interesting variety to the attendees
8. The festival will go on RAIN OR SHINE.
9. REGISTRATION FEES ARE NOT REFUNDABLE UNDER ANY CIRCUMSTANCE.
10. Each vendor will be responsible for his/her property. The Blacksburg Partnership and First and Main and their officers, agents, employees and volunteers are not responsible for any damage, theft, or loss for any reason.
